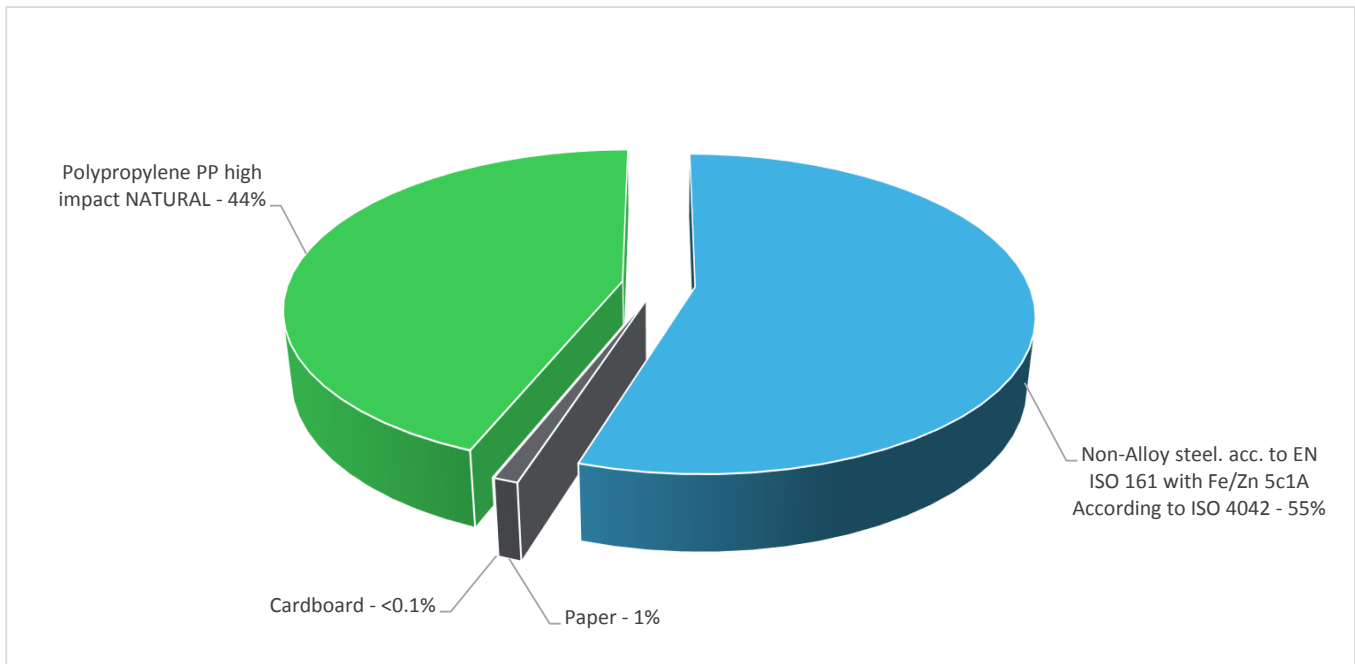
## General information

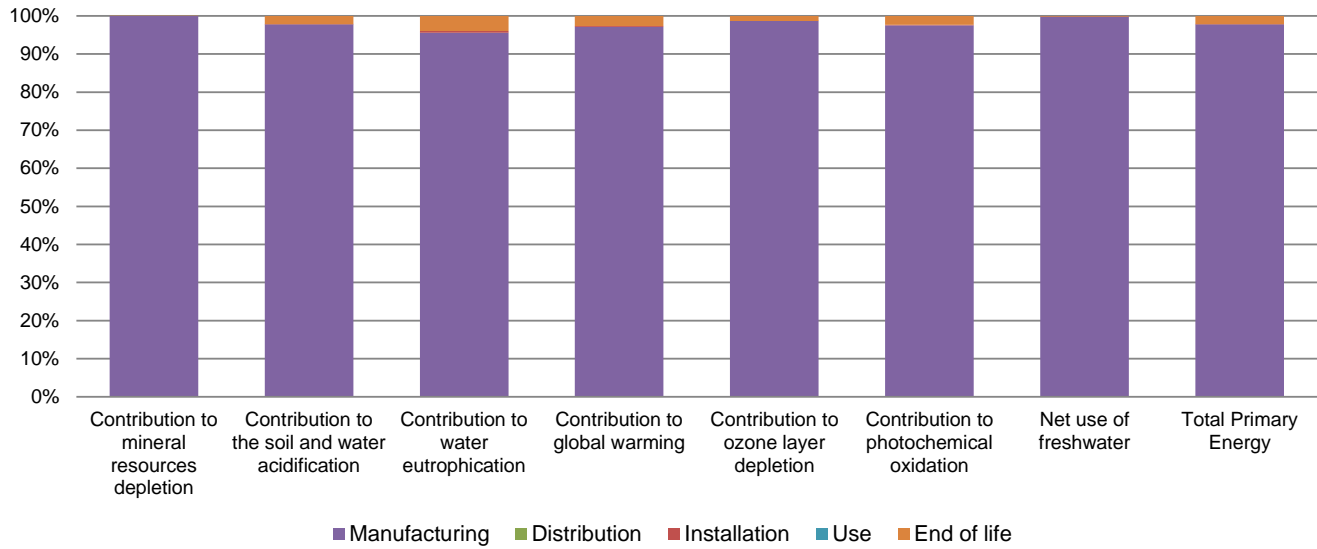
